One Hundred and Eighty-One (181) participants registered for the Webinar. The training was free of charge. Update on CEO of PEAs Conference

Registration for the Conference of Chief Executive Officers of Private Employment Agencies in Nigeria which will be organized by the Federal Ministry of Labour and Employment and Human Capital Providers Association of Nigeria (HuCaPAN) shall commence soon. This is a mandatory Conference for Chief Executive Officers of Private Employment Agencies in the country. As such, we expect all member-companies to register as soon as possible. The Conference will enable stakeholders in the industry to discuss issues that affect the industry and roles being played by the government in terms of policies, regulations and support. During the Conference, Standard Operating Procedure (SOP) for Private Employment Agencies in Nigeria would be officially unveiled. Details about registration and venue shall be communicated by the Secretariat soon.

Ban on International Recruitment and Standard Operating Procedure

I am glad to inform our members that the Federal Government has lifted ban on international recruitment. This followed series of consultations with the Government through the Federal Ministry of Labour and Employment, and other stakeholders' which resulted in the drafting and launching of the Standard Operating Procedure (SOP) for PEAs in Nigeria. However, for any international recruiter to operate, the Federal Ministry of Labour and Employment has directed that all licences must be regularized.

Upgrade of the Office Facility

The Association is soliciting support to upgrade the office facility and rent a new office space, but the response has not been encouraging. We appeal to members to support the Association to serve you better.
