Particularly, forward photocopies of your Company's Recruiters License and the Corporate Affairs Commission (CAC) Certificate to the Secretariat on or before Friday, August 18, 2023, and ensure subscription payment. ## National Electronic Labour Exchange (NELEX)

The Federal Ministry of Labour and Employment has informed your association, the Human Capital Providers Association of Nigeria (HuCaPAN) of the completion of the new NELEX portal. The NELEX portal has been recently updated and redeveloped with new and exciting features that aim to streamline the job search process and make it easier for job seekers and employers to find each other. NELEX allows job seekers to create profiles and upload their resumes, search for available job opportunities, and apply for jobs online. Employers can also create profiles, post job vacancies, and search for potential candidates based on their qualifications and experience. The platform is expected to play a significant role in Nigeria's economic development by promoting a more productive and efficient labour market. All Private Employment Agencies in Nigeria are mandated to register their companies on this portal and post available vacancies. These are part of the criteria for recruiters' licence renewal.
