On Friday, June 21, 2024, the revised Code of Conduct for Private Employment Agencies in Nigeria (2021) was launched at the United Nations House. The Code of Conduct has been printed by the International Labour Organisation and copies are available at the Secretariat. A soft copy has also been distributed to members-companies and can be downloaded from EAPEAN's website. Members are encouraged to obtain copies and to commit to its implementation.

## EAPEAN Membership Certificate

You know the transition from the Human Capital Providers Association of Nigeria (HuCaPAN) to the Employers' Association for Private Employment Agencies of Nigeria (EAPEAN). All member-companies must regularize their membership with the association without additional costs. Companies with such memberships must, however, have paid their subscriptions to date. In addition, every financial member will receive a new certificate if they have paid their subscriptions up to date. Companies that are up to date in subscription payments have been issued new certificates. We urge all members to pay their subscriptions timely to get the new certificate that bears our new name and logo.
